## **Important Notes:**

In light of the current Covid-19 situation and pursuant to the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Registered Societies) Order 2020, the adjourned 35<sup>th</sup> AGM will be held by way of electronic means as follows:

- a) Members will not be able to attend the AGM in person. They may only attend the AGM by observing and listening to the proceedings by electronic means.
- b) Under Article 11B of AWARE's Constitution, "Any member who wishes to place an item on the agenda of the general meeting may do so provided they give notice to the Secretary at least 2 weeks before the meeting is to be held." Members who wish to do this must send this by email to membership@aware.org.sg by 16 April 2020 and shall provide a description of item, brief background and purpose of raising item.

Any item submitted which concerns a matter that will be put to a vote will be addressed by AWARE's Board and/or Management before the closing date for the receipt of Proxy Forms on **25 May 2020.** 

- c) Members will not be allowed to submit questions live at the AGM. Instead, all questions must be submitted in advance by email to <a href="mailto:membership@aware.org.sg">membership@aware.org.sg</a> or by post addressed to AWARE, c/o Margaret Thomas, President of AWARE, 61 Bright Hill Drive #24-01 Bishan Point, Singapore 579653. The questions must reach AWARE by **25 May 2020**.
- d) We will endeavour to address all substantial and relevant questions submitted at the AGM but in the event we are unable to do so due to insufficient time, our response will be emailed to the sender or, if it is of general interest, posted on our website.
- e) A member wishing to exercise her **rights to vote** at the AGM may do so only by appointing the Chair of the Meeting as the member's proxy to vote on her behalf by:
  - i) filling in and submitting the Proxy Form (online version) here1; or
  - ii) downloading and filling in the <a href="mailto:Proxy Form">Proxy Form</a> (PDF Version) and depositing it with AWARE by email to <a href="mailto:membership@aware.org.sg">membership@aware.org.sg</a> or by post addressed to AWARE, c/o Margaret Thomas, President of AWARE, 61 Bright Hill Drive #24-01 Bishan Point, Singapore 579653; by **25 May 2020**.

- f) In filling in the Proxy Form, a member must give specific instructions as to voting, or abstentions from voting, in respect of a resolution. Failure to do so will invalidate the appointment of the Chair of the Meeting as proxy for that resolution. In the case of a candidate (Non-Standard Item), members can choose not to vote for any candidate by leaving the "For" column blank.
  - Members are encouraged to submit their Proxy Form via the online form (most convenient) or email as the postal service may be delayed by COVID-19 restriction orders.
  - Members may exercise their right to vote by proxy even if they do not attend the AGM by electronic means.
- (g) For details on how to attend the AGM by electronic means, please refer to **Zoom Instructions.**
- (h) The Candidates' information accessible <u>here</u> is confidential and made available for the sole purpose of enabling members to choose their candidates. All members shall keep confidential and shall not disclose or use, in whole or in part, the candidates' information for any other purpose except with the prior consent of the candidate concerned.

## Right to Vote Under AWARE's Constitution and Byelaws

- (a) Cat 1 members and Cat 2 members (including Life Members) who have paid their membership fees and who are not the subject of disciplinary proceedings are entitled to attend and vote at the AGM.
- (b) Associate Members who have paid their membership fees and who are not the subject of disciplinary proceedings are entitled to attend the AGM, and vote under the conditions set out below:
  - (i) Subject to sub paras (ii) and (iii) below, Associate Members are entitled to one vote each.
  - (ii) The total votes of Associate Members on any resolution shall not exceed 25% of the total votes of all members on such resolution.
  - (iii) In the event that, when voting on any resolution, the number of votes by Associate Members is greater than 25% of the total votes, then the Associate Members votes will be pro-rated so that they are equal to 25% of the total votes rounded down to whole numbers.

- b) in the case of the Non-Standard Item, for a candidate, please tick with a " $\sqrt{}$ " in the For box against that candidate's name. Do not select more than 8 Candidates, otherwise the vote for this item (vii) will be invalidated.
- (2) In the absence of specific directions in respect of a resolution (in the case of the Standard Items), the appointment of the Chair of the Meeting as your proxy for that resolution will be treated as invalid.
